Indigenous Women and volunteers as the co-chair of the Downie-Wenjack Fund Board of Directors. She is also a member of the Pathways to Education Canada Indigenous Education Advisory Circle and works to support the Alberta Joint Commitment to Action: Education for Reconciliation.

Charlene most recently served as the first Education Lead for the National Centre for Truth and Reconciliation at the University of Manitoba. Prior to that, she was the National Coordinator for Project of Heart and for the National Day of Healing and Reconciliation, the primary goal of which was to educate Canadians on the legacy of federal government policy on various ethnic groups throughout Canada's history and to promote respect and reconciliation.

Charlene coordinated the Education Days within the TRC National Events for the Truth and Reconciliation Commission of Canada, which focused on inspiring teachers and students to further educate themselves around the history and legacy of residential schools, as well as to support and facilitate the building of positive and respectful relationships between Aboriginal and non-Aboriginal people in Canada.

I.5 Roots of Empathy



Roots of Empathy is an evidence-based classroom program that has shown significant effect in reducing levels of aggression among schoolchildren by raising social/emotional competence and increasing empathy. The program reaches elementary schoolchildren from Kindergarten to Grade 8. In Canada, the program is delivered in English and French and reaches rural, urban, and remote communities including Indigenous communities. Roots of Empathy is also delivered in New Zealand, the United States, the Republic of Ireland, England, Wales, Northern Ireland and Scotland, Germany, Switzerland and Costa Rica.

Roots of Empathy's mission is to build caring, peaceful, and civil societies through the development of empathy in children and adults.

The focus of Roots of Empathy in the long term is to build capacity of the next generation for responsible citizenship and responsive parenting. In the short term, Roots of Empathy focuses on raising levels of empathy, resulting in more respectful and caring relationships and reduced levels of bullying and aggression. Part of our success is the universal nature of the program; all students are positively engaged instead of targeting bullies or aggressive children.

I.7 SLA (Student Learning Assessment) Resources – Quick Facts for Trustees

SLAs are a digitally based provincial assessment that provides a beginning of the year "check in". This enables parents/guardians and teachers to learn about and identify student strengths and areas for growth at the

start of the school year. The Grade 3 SLA is based on outcomes related to literacy and numeracy in language arts and mathematics in Alberta's current Grade 2 provincial programs of study. Some sets of questions are created using topics that may be familiar to students from other subject areas such as arts education, health, science, and social studies.

I.8 Review to Examine Workplace Health and Safety

The Government of Alberta is launching a review of the province's occupational health and safety system to improve workplace safety and better protect Albertans.

Alberta's *Occupational Health and Safety (OHS) Act* sets the minimum standards for workplace health and safety, and outlines the roles and responsibilities of employers and employees. While there have been small changes over the years, the act has not been thoroughly reviewed since 1976.

The review will examine the *OHS Act*, as well as compliance, enforcement, education, engagement and prevention efforts in Alberta's OHS system. It will also clarify employer and worker responsibilities, improve worker engagement and maintain Alberta's strong focus on illness and injury prevention.

KEY ACTION AREA #1:

Strong core instruction that develops student competencies

Literacy

- Crystal McGregor has been seconded from her principalship at Taber Mennonite School as the Secondary Literacy/English Language Learning Coach for the school year, as funded by the Classroom Improvement Fund negotiated between the provincial ATA and Alberta Education.
- In supporting our literacy initiative in the district, Terri-Lynn Duncan and Crystal worked with Barnwell Elementary staff in late August in the implementation of Fountas and Pinnell Benchmark Assessment in finding students potential of reading levels. There was also a portion of the day that was used to discuss and learn about the Fountas and Pinnell Levelled Literacy Instruction which is an intervention program for students who are struggling in reading.
- As of this school year, all Horizon schools will be aligning their practice by using and tracking universal assessment for all students. All schools have or will be implementing the Fountas & Pinnell Benchmark Assessment System, and will use that data to establish individual student learning profiles using the division's Dossier software.
- Terri-Lynn and Crystal have already worked with many new and continuing teachers to support the initiative above.
- Staff at Central School were led through a workshop on analyzing student running records looking at the meaning, structure, and visual information that students use in reading by Terri-Lynn. This will lead to better understanding of student comprehension and reading strategies used.

Numeracy

- The "Middle Years Math" project is underway in partnership with Amber Darroch, Dr. Richelle Marynowski, University of Lethbridge and with grant funding from the Alberta Research Network. Ten Horizon teachers representing 7 different schools are working together this year to identify best practice in math instruction and incorporate effective formative assessment strategies.
- A number of Grade 1 teachers are exploring the use of differentiation and assessment in math

instruction using approaches parallel to how we are teaching literacy skills. Six teachers are specifically part of a national study on Early Math Instruction by Pearson Canada, and an additional eight teachers are all receiving professional learning support in this area.

Assessment

- The remainder of secondary schools have come on board with the implementation of Horizon's learner-centred report card for junior high/middle school. Assessment Coach Sharon Skretting has played a key role in supporting teachers who have not used the software, Students Achieve, previously.
- Amber attended the Alberta Assessment Consortium (AAC) Board of Directors meeting on September 6 and will be working with neighbouring school divisions to participate in a regional assessment conference in Spring 2018.

Learning and Technology Policy Framework

 New robotics and coding equipment kits have been put into circulation this year so that schools have the chance to access innovative learning via Career & Technology Foundations (CTF) or other cross-curricular learning even at elementary. Kits include: "Lego Mindstorm", "Lego We Do 2.0", "Dash & Dot" and "Cubelets".

Other

- During the August start up days for the schools, the Learner Services team facilitated five
 professional learning events open to all interested Horizon teachers, and also supported
 targeted training at schools as requested. General PD sessions included:
 - o Read & Write Google
 - O SIVA Refresher Training (Supporting Individuals through Valued Attachments)
 - o English Language Learning
 - o Middle Years Math
 - o Learning Support Teacher Orientation.

KEY ACTION AREA #2:

Response to Instruction and Intervention Framework to improve literacy and numeracy proficiency

Collaborative Response

- Horizon's other Classroom Improvement Funded position, the Learner Success Coach, has been filled by Coral James who has been seconded from her vice principalship at Central School. Coral's initial activities have included classroom consultations with teachers with students already identified as requiring specific positive behaviour supports and joining in school-based collaborative response and professional learning community (PLC) meetings.
- The Directors of Learning and key school staff completed Collaborative Response Training with Kurtis and Lorna Hewston on tools to support the implementation of this software in five pilot schools (Milk River Elementary, Erle Rivers High, Vauxhall Elementary, Taber Mennonite, and Dr. Hamman Schools). Collaborative response is the ongoing consultation between classroom teachers, Learning Support teachers, and school leaders on the successes and supports needed for individual students in an inclusive learning environment.

Mental Health

- Family School Liaison Counselors have attended the opening staff meetings of all Horizon schools to promote a common understanding of the pyramid of counselling interventions available to students and how staff can help students to access these supports.
- The counselling team is pleased to partner with a new Alberta Health Services' Mental Health Therapist position working on a one-year temporary position with the Holy Spirit and Horizon School Divisions in Taber and surrounding communities. The MHT is responsible for a caseload of children and adolescents in the elementary, middle and high schools with mental health issues and additional complexities such as concurrent substance use. This position will work collaboratively with Family School Liaison Counsellors, other AHS professionals, community partners and natural supports to enhance the lives of these individuals in regard to mental health and concurrent disorders.

Early Learning

Across the division, there is a slight reduction in Early Learning enrollment and fewer children
than the trend in past years have been identified as requiring intervention as per Program Unit
Funding (PUF) parameters. However, every school with an Early Learning program has been able
to keep the program operating for the 2017-18 school year which promotes student
engagement and retention of students for Kindergarten next year.

KEY ACTION AREA #3:

Stakeholder engagement impacts student success

- Horizon welcomes 13 international students from Brazil and Spain for this first semester of the school year. Terri-Lynn provided a workshop for new homestay parents and the to ensure success for the parents that have opened their homes and for the students new to our division.
- To grow and support our international education program in our division Terri-Lynn hosted a tour to a chaperone/agent from Spain to all of our high schools. This tour has the potential of bringing 20 Spanish student to our division for one semester later this year or for the next school year.
- In support of the Nutrition Program funded by Alberta Education, Terri-Lynn and Darryl Moser hired a food service worker for Central School and have taken steps to set up the systems and equipment required to establish a successful program.

LEADERSHIP PRACTICES

- All of the Learner Services team members contributed to the Horizon Induction Program for teachers new to Horizon and those new to the teaching profession itself during the orientation event on August 24 & 25.
- Amber attended a provincial meeting in Edmonton on August 23rd representing the Executive of Southwest Alberta Regional Collaborative Service Delivery. Over the past number of years, numerous individuals and groups within the Community of Barnwell have been the impetus and financial support behind significant infrastructure enhancements to the Horizon School Division's Barnwell School Modernization Project. The Horizon School Division would like to take this opportunity to thank the Community of Barnwell for being a partner in making a difference in the lives of children in our schools. Not only have you supported school enhancements for the children of Barnwell through a significant enlargement of the school gymnasium, but you have enhanced services for all community members with the funding of a new community library and fitness facility, which is attached to the school. It is through collaborative partnerships such as this that we strengthen communities and enhance opportunities for all.

We recognize the extra-ordinary efforts taken by a large number of people to be able to bring this project to fruition and fully acknowledge the efforts required to fundraise \$2,086,975.

At the August 29, 2017 Board meeting Morgan Johnson spoke on behalf of a number of Barnwell community groups about a short fall in funding. At the conclusion of the presentation, Morgan made three requests to the Board of Trustees stemming from an unexpected shortfall in fundraising. Would the Board of Trustees of the Horizon School Division be willing to:

- 1. bridge finance an additional \$231,287 for 5 years for a total bridge financing amount of \$531,287?
- 2. continue to provide assistance to the Community of Barnwell with regard to the shortfall in funding?
- 3. Assist community groups in grant applications?

Following the delegation's presentation, the Board spoke very favorably about the community of Barnwell's efforts to successfully enhance the Barnwell School modernization project. The Board unanimously approved the delegation's request for enhancing the 5 year bridge financing to cover the entire outstanding amount of approximately \$531,287 without interest, on the condition

that the Board receive a signed commitment with regard to the agricultural donations, previously referred to as potato contracts.

While the Board of Trustees is not prepared to provide any additional funding to the project to cover the outstanding amount, the Board of Trustees has directed its senior leadership to continue to work with the community as it pursues grants and other forms of fundraising.

In closing, we look forward to many years of educating students in this amazing community asset.

Good morning,

A new school year is here and I would like to extend a warm welcome back and provide a brief update on a few Alberta Education initiatives.

One of our government's top priorities is seeing school construction projects completed as quickly as possible. I am pleased to say that more than 50 school projects are opening for students this fall, and thousands of Alberta students will enjoy classes in modernized and new schools in the 2017-18 school year.

Another priority is to make life better and more affordable for Alberta families. Through the implementation of *An Act to Reduce School Fees*, we are working to do just that. This is the first step, and we will continue to engage with our partners to achieve additional savings for Albertans.

Education legislation is also a critical part of ensuring all children in Alberta have access to a high-quality education. After thorough review, I have decided to consider amendments to the *School Act*. Subject: Fee Schedule Submission Update

Thank you for your June 30, 2017 fee submissions. I appreciate your effort and cooperation in meeting our deadline and supporting Alberta families. Prior to this, I extended the submission date to school boards for Non-Curricular Travel, Extracurricular Fees (which includes sports teams) and Activity Fees (which includes field trips) to September 15. Since that time, I have received some feedback from a few school boards indicating this extension is still a challenge in year one of implementation, as some of your schools will not have completed their planning in those three areas by September 15.

I appreciate that this process for school fees is in its first year of implementation and believe we can work together to make it as simple as possible. Thus, for these three specific fee categories, the per-student information originally required to be submitted on June 30 and previously extended until September 15 can now be submitted on a quarterly basis for the 2017/18 school year. School boards may submit for the Minister's review and approval, where necessary, an updated schedule for any Non-Curricular Travel, Extracurricular Fees or Activity Fees to Alberta Education, attention Brian Smith (edc.fra@gov.ab.ca), on November 30, February 28 and/or May 31. The per-student fee information for these three categories can be submitted using the same School Fee Revenue Schedule.

Please note that the regulation requires that no fees or costs are to be charged until they appear on the fee schedule and are submitted to the Minister for review/approval. Therefore, the levying of fees in these three categories should not commence until review and, if required, approval has occurred.

Thank you for your June 29, 2017 letter regarding the *School Fees and Costs Regulation*. I am also writing with regard to an article from the June 29, 2017 edition of the *Taber Times*. The article discussed the reporting of school fees and some areas of concern identified by senior administration and board members of Horizon School Division.

I understand that ministry staff have spoken to your central administration regarding both matters. Please know that if you or your board has questions or concerns with legislation or policy, you are always welcome to call my office to discuss them.

I realize that your school staff and central administration devoted significant hours to compiling school fee information. I am also aware that a compressed timeline to complete this task near the end of the school year is not ideal and does not allow much time for consultation with parents.

Government has chosen to implement an immediate solution to reduce school fees and make life more affordable for Alberta families. Although this has created some short-term challenges for school boards and the ministry, the issue is very important, and I could not delay action any further. Reducing school fees is a very ambitious and necessary outcome that government and school boards are working to achieve. This is a significant change from the status quo and, as a result, many issues and concerns arise. Reduced school fees will have a positive impact on many families within your school authority.

I also understand your concerns about schools not necessarily having all opportunities for students planned at the beginning of the school year. As a former educator, I realize that opportunities come up at various points throughout the school year. However, these opportunities need to be balanced with what families can afford to pay. As you know, I granted an extension for this fee category, which can be completed and submitted to the ministry by September 15, 2017. This extra time should give some schools and boards an opportunity to ensure no trips are missed.

Another option is to set field trip fees by grade. For example, a school may decide to set a field trip fee at \$50 for students in Grades 1 to 3. This provides staff with the flexibility to plan trips throughout the year instead of having all trips planned at the beginning of the school year. It also defines a budget within which staff have to work and provides certainty to parents related to the fees charged for this category.

With regard to your concerns related to the department's approval of your jurisdiction policies, we continue to respect the local autonomy of school boards. Local boards are in the best position to make decisions on behalf of their students and communities. However, I need to ensure this autonomy aligns with government's priorities and provides sufficient accountability to both the department and students.

The first year of implementation of any new process is a challenge, and we will learn a great deal from the fee schedules and policies boards are submitting. In future years, boards will be able to draw upon their experience this year and consult with parents sooner about their school fees.

I appreciate Horizon School Division's commitment to reducing school fees for Alberta families.

Dear Minister Eggen,

At the August 29, 2017 board meeting for Horizon School Division, the board passed a motion to amend our three-year capital plan for 2018-2021 priorities. The three top priority projects are the same but their order has been reshuffled as follows:

- 1. Erle Rivers High School
- 2. D.A. Ferguson Middle School / W.R. Myers High School Phase 2
- Lomond School

Erle Rivers High School was the board's top priority. It is listed on the governments unfunded capital projects addendum to the Budget 2016 Capital Plan, and on May 2 and 3, 2016 a valuescoping workshop was undertaken in relation to that school.

On February 16, 2017, the board amended our priorities and placed D.A. Ferguson / W.R. Myers phase 2 as the top priority and made Erle Rivers the second priority. This was in response to the board, staff and the community's displeasure with the impact that phase 1 of the D.A. Ferguson / W.R. Myers modernization was going to have on that structure. It was viewed that such a negative impact would be had, that phase 2 was urgently needed to make the facility functional.

The authority having jurisdiction changed its interpretation of how building code requirements would apply to the D.A. Ferguson / W.R. Myers phase 1 modernization. The scope of that project and the impact it will have on the facility is much more favorable than it was before this change in interpretation. These changes in plans have eliminated the urgency that the board felt for phase 2 of the D.A. Ferguson / W.R. Myers facility, and we have placed Erle Rivers as our top priority once again.
