Superintendents Progress Report April, 2021

Educational Leadership and Student Welfare

- Meetings and dialogue between schools and division office are ongoing. Conversations/topics
 typically focus on processes that ensure student safety, well-being, and conduct; financial
 management; and instructional leadership. This month included providing school
 administration updates related to tightening of COVID restrictions, conversations with Alberta
 Health Services (AHS) related to positive COVID cases and resulting quarantines, and other
 legal matters.
- As the president-elect of the College of Alberta School Superintendents, there are ongoing dialogue with other partner groups. Meetings typically involve provincial education perspectives, discussions. There is also normally a four partners meeting (Association of School Business Officials of Alberta (ASBOA), Alberta School Council Association (ASCA), Alberta School Board Association (ASBA), and College of Alberta School Superintendents(CASS)) and monthly Canadian Association of School System Administrators (CASSA) which includes representation from all Canadian provinces and territories.

Personnel Management

- Principal evaluations have wrapped up
- Work towards teacher allocations for the 2021-22 school year is ongoing
- Interviews for a new principal and vice principal for Milk River was completed. I am pleased to share that Rachelle Miller and Sandi Hughes will be the new administrative team for Milk River Elementary and Erle Rivers High Schools.
- Recruitment for a new early learning coordinator has also concluded. Ms Coral James was the successful candidate.

Policy and Strategic Planning and Reporting

- Planning for implementation of the new assurance framework is ongoing. Information for the new provincial assurance survey was shared with administrators. The survey will take place between March 20 and April 23 and guide future strategic planning.
- Meetings regarding career exploration are ongoing. Strategic planning sessions with Career Transitions have taken place as have logistical event planning for "EPIC" and a virtual University of Lethbridge career fair that connected graduating education students with Horizon.
- Extensive time was spent this month to discuss, plan for, and respond to the release of the draft curriculum.
- Time was spent with the administrations of D.A. Ferguson and W.R. Myers to discuss programming alignment of TMS students within the gr. 6-12 complex

KEY ACTION AREA #1:

Strong core instruction that develops student competencies

- Planning for the 2021-22 school year is underway, including Horizon's At Home Learning Program for Kindergarten through Grade 9, increasing the availability of online high school courses within the division, and planning how to maximize the use of outreach program resources.
- Ongoing project work to support quality teaching and optimal learning include the multi-division Hapara high school partnership, Education Forms software development for student learning supports, and supporting concept-based learning.
- Amber Darroch is working with high schools and regional partners to extend dual credit opportunities to Horizon students who wish to take courses at Lethbridge College in 2021-22 (IE. health care aide program, design fundamentals, animal science).
- The Learner Services team is consulting with school leaders and teachers on exploring the draft K-6 curriculum and preparing for mandatory curriculum implementation in Fall 2022.
- The Technology Team is investigating an alternative to the interactive projector or SMARTboards Horizon has been using in our classrooms. The Viewsonic interactive panel is a touch TV screen that comes with its own software that allows teachers and students to interact with files of any type, including SMARTNotebook. One panel is being piloted in an early elementary classroom and another at high school.

KEY ACTION AREA #2:

Response to Instruction and Intervention

• The Inclusive Learning Team has been busy this month in running developmental check-

- ups for the new students who are coming to Horizon in Early learning and Kindergarten.
- The Inclusive Learning team continues to support schools by attending the Collaborative Response Meetings, Instructional Support Plan Meetings and observations in classrooms.
- Horizon's Family School Liaison Program is running a series of 5 parent workshops and the first two - "Loneliness & Social Connection" and "Helping Your Child Control Their Emotions" - have been very well received. Subsequent sessions are being promoted through schools and direct communication home to families.

LEADERSHIP PRACTICES

- Terri-Lynn and Amber had a meeting with SWCSS (Southwest Collaborative Support Services) this month to start discussions about what next year would look like in terms of staffing. The SWCSS team members shared student success stories of their work across the Southern Zone. The therapists have done tremendous work in providing support to the diverse learners in our division.
- In the past month, Amber planned for and chaired both the Board of Directors meeting for the Alberta Assessment Consortium and the Provincial Advisory Committee for the Alberta Regional Professional Development Consortia (ARPDC).
- Amber attended a Zone 6 CASS meeting of system curriculum leaders to examine responses to the draft curriculum. This group will continue to meet regularly to collaborate on curriculum implementation work and related topics.

Some highlights during February, March, & April include:

- Professional Learning was highlighted in March as teachers engaged in a site-based PD day, followed by a division-wide day. During both of these days, teachers and principals engaged in deepening their understanding of conceptual learning through focused learning experiences. School-based PD opened up opportunities for schools to learn in small teams, and determine the context suited to their needs. One school used a self-paced process of videos and practice to learn new technology supports (Hapara and Formative) for instruction. Another stepped through an asynchronous experience focused on learning for transfer and new models of planning available. At yet another school, teachers were furthering a schedule of implementing new learning associated with Learning for Transfer, as I supported them in their development of shifted unit planning. Overall, the momentum is strong in Horizon, as principals create structures to support teachers in their quest to provide progressive, research-based practices for optimal learning.
- Several schools have structured team approaches to professional learning. These structures include cycles of half day learning, a series of after-school staff meeting learning, and in-school collaborative team learning. Our shift to utilize virtual options for meetings has opened up accessible access to such cycles and it is just this cyclical approach to professional learning that research supports as impactful. As a highlighted example, one particular school includes one teacher representative from each of their four divisions, working in a cycle of four, half-day meetings where theory and practice is focused on. We have one final team meeting and the growth has been truly incredible. These five teachers will act as leaders for their entire staff as the new curriculum is released and professional growth continues. Bolstering teacher leadership is essential in sustaining a strong team of educators and I am very excited to be a part of this continued growth with this staff.

On behalf of the Board of Trustees of the Horizon School Division we are sending this letter to provide our perspective about Bill 52, Recall Act.

While we believe in the government's efforts to strengthen democracy and accountability in our province as well as empower citizens, we do have some questions and concerns we wish to share with you. As we reviewed Bill 52 we could not help but notice that MLAs are being treated differently than counsellors and trustees. While we agree that the threshold for prompting a recall vote should be different in municipalities and school divisions of different sizes, to address the real concern of making it too easy for a few people in a small town or school board ward to unseat a mayor, councilor, or trustee, we noticed that in the case of trustees that should the petition garner adequate signatures that trustee would be automatically evicted as compared to having an election. We questions why the difference in this regard?

We also note that section 96.6 of the bill states,

"(1) A recall petition must be signed by electors of the ward or division, as the case may be, as determined under section 96.5, that are equal in number to at least 40% of the number of electors.





- (2) Subject to subsection (3), on the publication of a notice of recall petition under section 96.3(8)(a), a board shall, subject to the regulations, if any, conduct a census of the ward or division to determine the number of electors.
- (3) A board is not required to conduct a census under subsection (2) if one has been conducted since the general election immediately preceding the publication of the notice of recall petition under section 96.3(8)(a)."

School boards face a couple of challenges in determining a list of eligible voters:

- School board electoral wards do not always align with municipal and county boundaries, as such, available census data does not provide an accurate count of eligible voters.
- We were informed by one of our municipal governments that they were no longer going to conduct a local census; their intent was to rely on the federal census. School divisions are not able to drill down to the school ward level to determine eligible voters or number of eligible voters using Stats Can census data. In rural Southern Alberta there is also a high percentage of Low German Mennonite families. We believe a large percentage of these families are missed in the federal census. As such we do not believe the federal data accurately reflects the true population.
- Where a separate school district is established, an individual residing in the boundaries of the established area is considered a separate school elector if they declare they are of the same faith (either Protestant or Roman Catholic) as those who established the separate school district. A separate school elector is eligible to be nominated as or vote for either a public school trustee or a separate school trustee for the school board in which the person resides (not both).

The Horizon School Division has never appointed enumerators to determine a complete voting list. We have always used an Elector Register instead. The only way to reliably overcome these challenges would be for a School Board to appoint enumerators and establish a current voter list at the time a recall petition was completed.

As such, should a petition arise, school boards would be in a situation whereby they would need to spend a significant amount of funding to undertake a census of a ward in order to determine whether the petition has surpassed the 40%





mark. We do not believe that expending educational dollars on a census is a wise or prudent use of dollars that are intended for the classroom.

We look forward to a resolution to these issues as the bill works its way through the legislature.

By focusing on financial literacy, Alberta's government aligns with the <u>Ministerial Order on</u>
Student Learning released last fall. Developed following consultations with parents, teachers

and education experts, it calls for students to acquire competence in managing personal finances.

Financial literacy was also among recommendations from Alberta's independent <u>curriculum</u> <u>advisory panel</u>. In their report, the panel noted students may leave Grade 12 without the basic skills necessary to transition successfully into life after high school. They recommended financial literacy, work readiness, wellness and goal-setting to enhance student learning.

As part of the work to refocus on essential knowledge in Alberta's elementary schools, financial literacy is also a key component of Alberta's <u>draft kindergarten to grade 6 curriculum</u>, under the theme of <u>practical skills</u>. In the draft, all students will study financial literacy in all subjects and grades – from counting coins to creating a budget.
